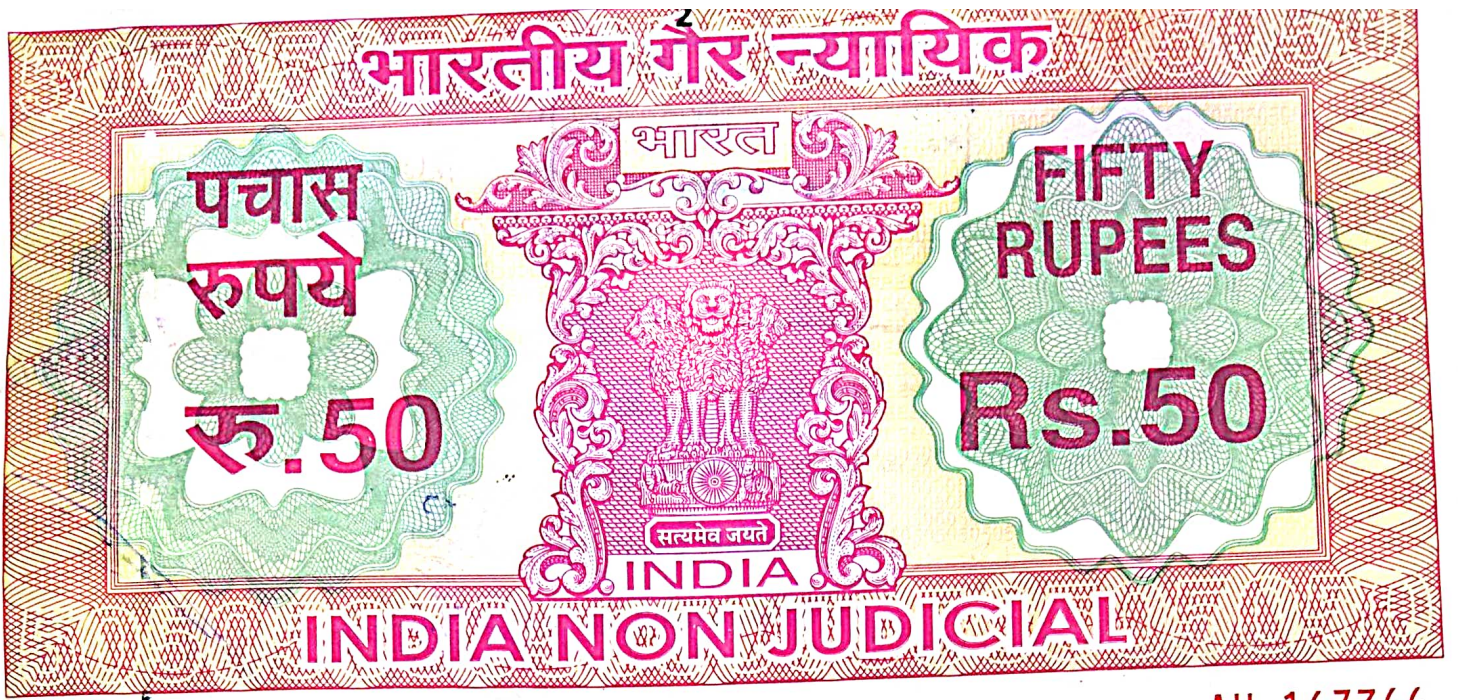

WHEREAS: The Trustees is desirable to establish a fund for Public charitable objects.

3. **BOARD OF TRUSTEES:** That Trust shall be administered by a Board of Trustees (hereinafter referred to Board). The Board will have office bearers like President, Vice-President, Secretary, Treasurer from amongst the members of the Board of Trustees.

I. - V. To organize social, Cultural program and annual sports and quiz competition for youth and children and aged people with the help of State Government and Central Government and other organization.
- VI. To establish a modern library for our society.
- VII. To organize vocational guidance camps, discourses, impart training in different income generating skills, creation of self-help group for women/ adolescent girls to enable them manufacture marketable goods and in procurement necessary finances from Bank/ Social Welfare Board/ Government of India/ State Government.
- VIII. To establish Vocational Training Institute with the help of State Government and Central Government.
- IX. - XI. To establish general degree colleges, B.Ed, D.El.Ed as well as management and technical degree and Diploma course and Polytechnic Courses.

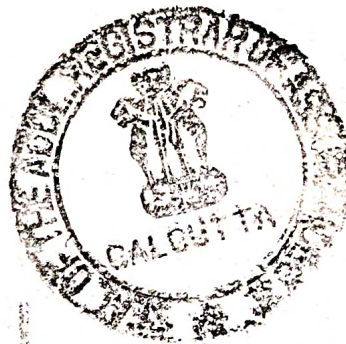

- XII.** To organize, run maintain ORPHANAGE with its branch or branches in India for children between 3.5 and 5 years of act to rear them up and help them to be rehabilitated and established in life.
- XIII.** To establish, run, maintain and/or grant OLD AGE HOME with branch or branches anywhere in India for the infirm, disabled and physically handicapped or crippled persons.
- XIV.** To provide computer education and to open computer center for betterment of youth.
- XV.** To establish, maintain and/or run scholarships and other kind of aid to needy students, including supply of books, stipends, medals and other incentives to study and to provide board and residence for poor students in general.
- XVI.** To conduct Skill development program for knowledge based society.
- XVII.** Plantation of maximum tree to protection the environment in entire India as well as entire world. The target of the trust is to plant trees equal to world population.
- XVIII.** To organize Blood Donation and social awareness campaign among the youth.
- XIX.** To help and grant aid to the poor and destitute people, orphans and widows, tribal and deprived people.
- XX.** To promote and form Self Help Groups (SHGs) for the self employment.
- XXI.** To establish and manage Coaching and Information Centers for the benefit of the student and youth.
- XXII.** To do any other acts for the advancement of general public utility not involving the carrying on of any activity for profit, without distinction of caste, color or creed.

All aims/objects/purpose of the trust herein stated above shall come into effect/force/ after necessary approval of competent Govt. authority in the cases where affiliation/permission/license/sanction is required.

The trustee shall not collect any money from the general public/ open market by using the trust name and provoking then any gainful profit which is totally illegal and all the trustees and the trust are come under the all punishable civil and criminal and PMLA law and the trust is null and void.

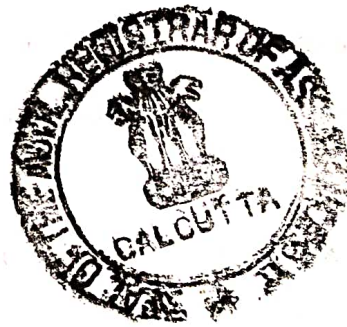
2) To formulate a scheme or schemes for he carrying out any of the objects of this trust and for management of the trust property and to frame any scheme or schemes, rules and regulations from time to time to achieve the aims and objects of the trust hereby crated.

3) The TRUSTEES shall cause true and accurate accounts to be kept of all moneys received and spent and of material in respect thereof in course of management of Trust Fund or in relation to the carrying out of the objects and purpose of the Trust as well as of all the assets, credit and effects of the Trust Fund.

4) For the furtherance of the objects of the Trust, the trustees will have the following powers which will be exercised by them in accordance with the accordance with the provisions of the income tax Act, 1961 and the Income Tax Rules, 1962, force from time to time.

a) To accept any donation, contribution, grant or subscription in cash or in kind from any person, body or persons or trust, maintaining all legal norms as valid documents.

b) To apply the whole or part of the income of the Trust Fund or accumulation thereof or whole or part of the corpus of the Trust Fund for any one or more of the objects of the Trust/ Trustees may in their discretion from time to time determine.

c) To convert and deal with investment comprised in the TRUST FUND and/or to carry the investments for time being.

d) To let out or demise any immovable property comprised in the Trust Fund for such period and at such rent and on such terms and conditions as the TRUSTEES in their discretion may think fit.

5 a) To open bank accounts of the trust in the name of the Trust by the President and Secretary in any scheduled or Co-operative Bank or Nationalized Banks as may be decided upon by them from time to time and to close such accounts and to open new ones in any such Bank or Banks and providing the operation by jointly with President and Secretary or President and Treasurer or any two of them.

(b) The Trustee or trustees shall cause proper accounts to be kept of the trust fund and all additions thereto and the income thereof respectively and the accumulations of such income and the application thereof from time to time shall on checking the same sign the account books twice in each year. The account books so signed by the trustees shall be examined, audited and certified by one or more properly qualified auditors once in each year and the audited statements of accounts shall likewise be signed by all the trustees.

(c) To hold meetings and conference on the matters related to the improvement and advancement of the trust fund.

(d) All accounts in the banks shall be maintained in the name of the trust or trustees and will be operated by any two or more trustees as may be decided by them from time to time.

(e) The trustees shall maintain a register of the trust fund and its investments and shall keep it up to-date by making additions to or alterations in the same as and when the new investments are purchased or acquired or invested by the trustees. The Trustees shall physically verify the list or register at least once a year.

6.a) To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceedings regarding the trust fund.

b) To appoint or make provision for the appointment of any person (including all or any of the TRUSTEES as committee or administrator or managing Trustee or otherwise) for the purpose of the administration of the trust in such manner and subject to such rules and regulations as the TRUSTEES may prescribe and also to appoints or provide for the appointment of separate Trustee to hold any property or any fund or investments, subject to the provisions of this deed in such manner and subject to such rules and regulations as the TRUSTEES may time to time think fit.

c) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the managements of the affairs thereof and of running and institutions further of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

d) To start, abolish, discontinue and restarts any charity or charitable institution for the benefit of general public and to impose any condition to any subscription or donation made by them.

e) To set apart or accumulate the whole or part of the income or the corpus of the Trust Fund or part thereof for any subscription or donation made by them.

f) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects having kindred or allied objects upon such terms and conditions as

TRUSTEES may in their discretion think fit particularly having regard to the objects and nature of the trust.

7) The TRUSTEES shall be chargeable for such moneys, stock, shares and funds as shall actually come in their hands and a TRUSTEES shall be answerable or accountable for neglect, default, acts of omission or commission of the other TRUSTEES, nor of any banker or other person with whom the TRUST properties or any securities comprised in the Trust Fund have been deposited or kept.

8) The receipt of a person authorized by the TRUSTEES or a resolution of the board of trustees, for any money paid or any property transferred or delivered to the TRUSTEES in execution of any of the powers thereof or for the purchase money of any property authorized to be sold shall effectively discharges any persons so paying or transferring or delivering.

9) a) The number of trustees shall not be less than 2 and not more than 15. However general member of the trust can be anyone based on the acceptance of President or Secretary of the trustee board. The TRUSTEES for the time being will be at liberty to appoint additional TRUSTEES within the number mentioned above for such period or on such terms as to retirement an reappointment as the TRUSTEES for the time being consider proper. The TRUSTEES appointed by these presents will be for life. If any TRUSTEES died, retires, becomes unfit or incapable to act, resignation or otherwise the continuing or surviving TRUSTEES or TRUSTEES will be competent to appoint a Trustee in place of the Trustee so dying, retiring or becoming unfit or incapable to act either for life or otherwise as aforesaid. A person shall cases to be a TRUSTEE either a) if he/she do any act which violate the terms and conditions of the trust, or b) if he/she if requested to resign by all the other TRUSTEES.

b) Every TRUSTEES will have liberty to resign on giving one month's notice of his/her intention so to do and with the consent of any on trustee member.

c) If anyone from Trustee board member is found to be unlawful, guilty or harmful. He/ she can be suspended by the trustee board with consent of two third majority and issue will be investigated by 3 member impartial committee headed by Secretary. Report will be submitted to President and President will take decision of expulsion of that member based on the report. After that it has to be passed in board with two third majority.

10) The trustees may from time to time frames rules for the conduct and regulation of the meeting of TRUSTEES.

In the absence of such regulations :

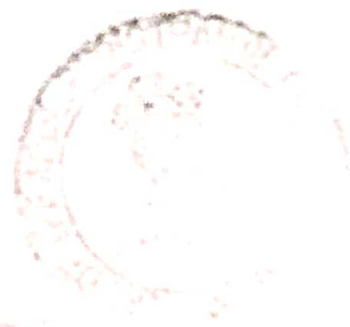
a) Two TRUSTEES shall form a quorum for meeting of the TRUSTES.

b) All matters will be decided by majority.

c) Resolutions passed without any meeting of the TRUSTEES but by circulation thereof and evidenced in writing under the hands of two-thirds of the TRUSTEES shall be valid and effectual as a resolution duly passed at a meeting of the TRUSTEES.

11) The accounting year of the trust shall be Financial year (1st April to 31st March, next following), unless changed by the TRUSTEES by two-thirds majority.

12) It is expressly declared that no part of the trust property or its income or Trust Fund shall be applied for any purpose outside India or for any purpose which is not a public charitable purpose in law and all provisions hereof shall be constructed accordingly.

I. BENEFICIARIES OF THE TRUST:

The Trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste, religion, creed or sex.

II. PROPERTIES

The Trust properties shall consist of:

- 1) The amount Transferred by the SETTLOR as mentioned above, towards the Corpus fund of the Trust.
- 2) Any cash, kind, properties, movable and immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in or over any property movable or immovable.
- 3) All additions and accretions to the Trust properties and the income there from
- 4) All donations, gifts legacies or grants, in cash or kind accepted by the Trustees upon Trust, maintaining all legal norms as valid documents.
- 5) The properties of the Trust shall be utilized for the objects set forth herein above and subject to the provisions and conditions herein mentioned.

III. TRUST ADMINISTRATION AND POWER TO THE BOARD:

A. The Board of Trustees shall have power to:

- a) To administer the Trust, its properties and affairs and do all the things which will fulfill the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.

- b)** The income and the properties of the Trust will be solely utilized towards the objects of the Trust and no portion of it will be utilized for payment to the Settlor or Trustees or their relatives by way of salary, allowances, profit, interest, dividend etc.
- c)** To open one or more bank accounts and operate the same or provide for operation of the said accounts by any two among them authorized on their behalf.
- d)** To invest the Trust funds in the manner not prohibited by any provisions of the Income Tax Act, 1961. The trust has investments as per Section 11(5) of the Income Tax Act, 1961.
- e)** To receive, collect and enforce recovery of all monies due or payable to the Trust and grant receipts and discharges therefore.
- f)** To settle, compromise or compound any disputes or refer the same to arbitration or litigation.
- g)** To receive voluntary contributions from any person or persons from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
- h)** To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.
- i)** The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust.
- j)** No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund/property.

k) The Trustees shall hold honorary office and shall not be entitled to any Salary, allowances or perquisites, except for the reimbursement of actual expenses incurred in connection with attending to the Trust matters.

l) The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income Tax Act, 1961.

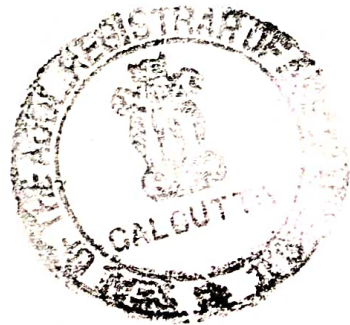
m) For the management and administration of the Trust, the Trustees shall elect one amongst themselves for each of the offices of President, Secretary and Treasurer. The term of office for Secretary, President and Treasurer shall be for a period of one year from their date of appointment and they may be reelected for further terms.

IV. Function of Trust:

a. The trust will never acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country in connection with sec 4 for which the trust and the trustees are responsible for that and the whole trust is void, and come under the all punishable laws.

b. The trust will never acts like Micro financing and Money laundering (Act-2012) in nature and shall not obtain any donation or like that from abroad without getting permission of FCRA ACT from the Central Govt./ the competent Govt. authority which the trust and the trustees are responsible for and the, the whole trust is void and come under the all punishable laws.

c. The Trust will never acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country for which the trust and the

trustees are responsible for that and the whole trust is void and come under the all punishable laws.

d. The Trust shall not borrow and / or augment money from the public or open market by announcing attractive financial investment scheme.

e. All donation and Gift from any one individual or Institution or any corner shall be accepted by maintaining all legal norms and valid document /receipt.

V. FUNCTION OF OFFICE BEARERS :

Secretary:

The Secretary of the Board of Trustees elected under the control and supervision of the Board, shall conduct and manage all the affairs of the Trust, its properties and institutions, sign papers and carry on correspondence on behalf of the Trust and shall be responsible for the safe custody of records of the Trust and the keeping of proper accounts thereof. The Secretary shall attend to the correspondence and day to day affairs of the Trust. He shall have the custody of the correspondence and other books relating to the Secretary under the clause. The Secretary shall attend to the correspondence and day to day affairs of the trust.

President:

- i) President will be elected by the majority of the Members (Trustees) present in the meeting convened for that purpose,
- ii) The President will preside over the meetings of the Trust and conduct the proceedings.

- iii) The President in his own discretion or by the request of one-third of existing members can call for a meeting of the Trustees,
- iv) The President is empowered to delegate such powers to the Vice-President or any other members of the Trust as he may deem fit.
- v) Three member impartial committee will be formed by President this committee will investigate the issues and submit the report to the President. The impartial committee consists of Secretary and two other members selected by President.

Treasurer:

The Treasurer shall collect and receive all sorts of subscriptions, donations and deposit of money and grant receipts of money thereof. Treasurer will maintain and keep Cash Book and such other accounts as are necessary.

VI. MEETING OF THE BOARD OF TRUSTEES:

The Board of Trustees should meet at least once in every calendar quarter and may meet more often when required.

1. The meeting of Board of Trustees shall be convened by the President and he shall preside over the meetings. In his absence, the President may authorize the Vice-President to be the Chairman of such meetings. In the event the President or Vice-President are not able to attend the meeting already convened, any of the Trustees present in the meeting may elect one amongst themselves to be the President of the meeting.
2. All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the President presiding over the meeting shall have a casting vote.

3. Any resolution in writing signed by all the Trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees.
4. The meeting of the Board shall be conveyed after giving at least a week's notice unless all the Trustees agree to accept a shorter notice.
5. The Board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meetings of the Board, but they shall not be entitled vote in the meetings of the Board.

VII. INVESTMENT OF TRUST FUNDS:

1. The Board of Trustees shall have the power to invest the funds, assets and properties of the Trust at their discretion in accordance with the provisions of the Income Tax Act, 1961.
2. The Board shall also determine from time to time, the amount it shall spend on the various activities of the Trust.

VIII. ACCOUNTS AND AUDIT:

1. The financial year of the Trust shall be from 1st April to 31st March of the following year, unless otherwise decided by the Board of Trustees.
2. The Board of Trustees shall maintain true and correct accounts of the Trust.
3. The accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within three months of the close of the financial year.

IX. AMENDMENTS:

1. While this trust shall be irrevocable, the Board of Trustees may amend any of the clauses except those relating to objects of the trust, the First managing Trustee and First Trustees, at a duly convened meeting of the Board with at least 2 Weeks notice, and by a resolution passed by at least three-fourths majority of the Board of Trustees present and voting. The amendments to the Trust Deed can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation.
2. If any alteration or amendment is necessary, the same shall be affected through supplementary deed/deeds with the previous approval of the Commissioner of Income Tax and these shall be read together with the main Trust Deed.

X. INDEMNITY: The Board of Trustees shall be indemnified for any act done by them in good faith in the course of the administration of the Trust.

XI. APPLICABILITY OF TRUST ACT:

The provisions of the Indian Trust Act 1882 shall apply to all matters not specifically mentioned in these presents violating the same in any part, the whole trust is void.

Lawful Purpose: A Trust may be created for any lawful purpose. The Purpose of a trust is lawful unless it is : (a). forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or (d) involves or implies injury to the person or property of another, or (e) the Court regards it as immoral or opposed to public policy. every trust of which the purpose is unlawful is void, and where a trust is created for two purposes, of which one is lawful and the other unlawful, and the two be separated, the whole trust is void.

XII. APPLICATION OF INCOME TAX ACT:

(1). To perform that notwithstanding herein contained in the income as the corpus of The Trust fund the same shall be applicable and applied to for Public Charitable Purpose Only within such territories and subject to such conditions or limitation if any as may from time to time be laid down by the Income Tax Act, 1961 or any other acts governing taxation of Income the wealth of Public Charitable Trust so as to render the trust hereby established as well as its income eligible for exemption from taxation under such Act or acts, now or prevailing or any modification replacement thereof.

(2). To act in such a way that the Trust hereby established shall always retain the status of one such trust to which provisions of section 80G / 12 A/ FCRA/ 35 AC/10(23C)IV/V/VIA of the Income Tax act, 1961 or any modification replacement or thereof for the time being in force shall apply so that any donation or contribution thereof is recognized as eligible for exemption or relief from tax in the hands of the donor.

XIII. DISSOLUTION:

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left if any, shall be disbursed to other Trusts or Associations having similar objectives after obtaining previous approval of Commissioner of Income-Tax and in no event it shall be distributed in any manner, to any of the Board of Trustees or their relatives or related concerns.

Area of Jurisdictions of operation: Area of jurisdictions/ operation of the Trust in the whole of Indian but preferably in the state of West Bengal and particularly in the limits of Kolkata Municipal Corporation.
